-  To adhere to the international standards of traceability, Lecilite has implemented Identity Preservation Programme certified by FOODCHAIN ID (formerly known as CERT-ID). All our Soy products are 100% non-GMO and based on PCR analysis - transgenic DNA, Roundup Ready (RR) soybean, 50 cycle 35S-Promoter, NOS-Terminators, Fig Mosaic Promoter, Cotton Reference Gene etc.
-  We have a robust system in place to fully trace-back the sourced beans which were used to make the batch. All along the value chain we follow stringent checks to make sure our customers receive the quality and 100% non Genetically Modified products.
